The meeting was called to order by President Frank Fruh at 8:02 p.m. Scouts of Troop 424 presented the colors and led the membership in the Pledge of Allegiance. Paul Goodwin offered the invocation. Tony Barnett, Treasurer, John Fitch, Ways and Means, and Dave George, Property, were absent. Fifty-two members and guests were present, 47 signed the roster.	Membership : In the absence of Dave George, Phil Lang introduced two prospective members, Christopher Krause, sponsored by Clay Starner and George Snellings III, a returning member. The prospective members were asked to leave the room and a motion was made to accept them into membership. The motion was seconded and passed and the new members were welcomed into the club.
President : Frank Fruh reported that July was a very interesting month and August is starting off just about as interesting. A hail storm came through and damaged the hall. We are working with the insurance company to get that repaired. We made major strides with ACPT and the new lease. Mark McFarland had his lawyers write the lease and we need to remove most of the document. We should have a presentable lease shortly. The Boy Scouts came out on Saturday and did some landscaping for us at Middleton Hall. Frank donated water and ice cream to help them cool off.	Committee Reports High Power: John Leber reported that he will now be the match director and Jim Greer volunteered to be match supervisor. We are finished shooting high power for the year. Anyone can shoot in any match we have. These matches also qualify you for CMP purchase of a rifle. The match director does all the paperwork and runs the match. The match supervisor signs the paperwork for mailing to NRA.
First Vice President , Marlene Smith reported she is creating a key list to keep track of who has keys to the range and Middleton Hall. Ways and Means: In the absence of John Fitch, President Fruh announced that 50/50 tickets are being sold and reminded members of the upcoming family picnic on Sunday, September 12 at Middleton Hall, 1 p.m. till 4 p.m. Raffle tickets were printed in the August <i>Recoil</i> and he encouraged members to buy and	Junior Rifle: Perrin Lewis reported that the match was held at the indoor range on Sunday. Legislative: Gus Steinhilber reported the castle law was upheld recently during a home invasion incident. Three states have passed laws to permit carry. Maryland has not yet voted on the issue.

Mountain Property: Jim Pollock reported supplies are being gathered and work will begin on the temporary shed to be constructed at the mountain property after the weather breaks. Volunteers will be called as the construction date nears.

Outdoor Range Cleanup: Charlie Embody reported that the range will shut down operations for cleanup on August 31. We sent out requests for bids to the four companies who showed an interest in doing the cleanup. Only two submitted bids. Of the two bids, Marcor is very reputable and has a thick resume of ranges they have cleaned up. The two prices we got were \$140,000 from MT2 and \$98,500 from Marcor. We would like to have Marcor do the work. We will ask for the money, print the request in the Recoil, and vote on it at the next meeting. Jim Pollock stated that we can vote tonight for Marcor to do the work and vote next month for the funds. President Fruh reported there was a special board meeting to discuss the two proposals, reviewing them line by line, item by item. Marcor presented the better looking package at the lower price. It appears to be a fixed price while the other company indicated if more work was required, the price would increase. John Leber stated the Recoil needs to be corrected to indicate the correct cease fire date. After midnight September 1, there will be no more firing on the outdoor range.

Silhouette: Brian Rehm reported the last match will be August 28. Preregistration is not required but appreciated. Come out and enjoy shooting with us.

Unfinished Business: Paul Goodwin asked if everyone had a chance to read the motion printed in the Recoil regarding ceasing printing paper copies of the newsletter. The Recoil will be made available electronically to save about \$8,000 per year over sending out paper copies. He reported his labeling team feels it is a waste of time to label the newsletters which takes about three and a half hours. Anyone who does not have access to a computer can simply contact Dave George and he will print a label and it will be sent out. This change will save us \$8,000 a year, over five years that \$40,000 for range development. The motion was read and received a second. Further discussion included a statement from a member of the labeling committee agreeing that it does take a lot of time. Postage costs about \$250 and up, depending on weight. If we decide to go the electronic route, he suggested a blast email be sent to the membership advising them that the latest *Recoil* is now available on the web site. A member stated he would be willing to pay an extra fee for a paper copy. Another member reminded the membership that the treasurer was to provide a per-issue per-member cost for the newsletter. In the treasurer's absence, this information was not available. Costs were then discussed. A member suggested including a link to the web site in the blast email to members. Discussion followed regarding when to begin charging members for a paper copy. The Recoil will be printed one more time with a notice to members that this will be the final issue. The card vote was called and the motion passed.

Paul Goodwin made a motion that anyone wishing to receive a paper copy will be assessed the cost of printing and mailing the *Recoil*. The motion was seconded. Discussion followed concerning the actual cost and means of collecting the fee. Brian Malpasso offered an amendment to the motion that any cost incurred would not be effective until 2011 dues renewal. After further discussion, Brian Malpasso then offered a motion to table the motion. A vote was called and the motion to table passed.

New Business: Charlie Embody made a motion to accept Marcor as the lead remediation firm for the outdoor range. Work will start in September. The cost will be printed in the *Recoil* for a vote at the September membership meeting. The motion was

seconded. A member asked to see an outline of work to be done. President Fruh stated that an outline will be provided at next month's membership meeting. The bottom line is, Marcor will do the job for the price quoted and give us a certification that the lead removal has been completed. ACPT requires a certification that the lead has been remediated to a certain level. Marcor will do this and provide certification to ACPT. Cindy Perkins asked if members would be able to review the Marcor proposal, licenses and certification to do this kind of work. President Fruh stated SCSC received an RFP from Marcor with this information in it and it was available for review. Charlie Embody will give the RFP to Cindy Perkins for her review. All this motion does is accept Marcor as our contractor. We cannot spend funds until the membership approves the funds after it is published in the Recoil and voted on at the September meeting. A vote was called and the motion passed.

Jose Torres stated that outdoor range cleanup will begin this Friday and Saturday and continue every Friday and Saturday in August beginning at 4 p.m. on Friday and 10 a.m. on Saturday to start cleaning the range. We will not stop anyone from shooting. We have to start clearing some of this stuff out and consolidating what's in the trailers.

Jim Pollock made a motion to secure from the Land and Building Fund \$98,500 to pay Marcor for the work they will be doing at the outdoor range. The motion was seconded. The motion will be published in the September *Recoil* for membership review with a vote to be taken at the September meeting.

Henry Bernatonis suggested that the club hold a swap meet to raise funds for the club. He will present a proposal at the September membership meeting.

Good and Welfare: Perrin Lewis stated he has tickets left for the Friends of the NRA pistol raffle to be drawn at the Annapolis FNRA banquet on August 21. The winner of the Thompson was Kurt Kingsbury.

Frank Fruh stated that he will begin his 4H shooting program at the end of August for youth between 12 and 19 years of age. They will shoot trap, skeet and sporting clays. There is a state match in November they will be training for. Shooters over 15 will be able to shoot their way onto the state team and travel to the national competition next June. If you know of any youth who are interested in learning how to or knows how to shoot trap, skeet and sporting clays, please contact him.

The 50/50 of \$44.50, was won by Randal Browning. Andy White won the workers' drawing for IPSC. The meeting adjourned at 9:08 p.m. Respectfully submitted, Elaine Costello, Secretary.
